Fees	About \$15,500, but there is an automatic 10% Clemson discount and \$500 - \$5,000 scholarships are available based on need and merit. There is a \$200 registration fee for INT 2010.

Coursework	12-17 credit hours for spring and fall semesters (4 credit hours of internship, 8 credit hours or seminar, and 3-4 credit hours of electives or research) and either 3 or 6 credit hours for summer semester. Enrollment in Clemson's INT 2010 will maintain your student status with Clemson.

Financial Aid Partnership	Based on academic merit and financial need ranging from \$500 - \$1,000
Fees	Spring and fall tuition costs approximately \$16,000 (plus \$1,000 for student fees and insurance). Summer tuition costs approximately \$4,100 for 3 credit hour or \$8,100 for 6 credit hours (plus approximately \$500 for insurance). There is a \$200 registration fee for INT 2010.
Paid Internships	Mostly unpaid
Enrollment Status	Full-time through American University; however, it is strongly encouraged to maintain enrollment status at Clemson University by enrolling in INT 2010 off-campus internship course.
Room/Board	Spring and fall semester university housing is available for \$5,200 - \$6,700 (meal plans range from \$1,500-\$1,800). Summer semester university housing is available or \$280 - \$350 per week (meal plans range from \$450 -\$850).
Application	Students must be recommended by Clemson University

Coursework	15 hours transferred from USC; Enrollment in Clemson's INT 2010 will maintain your student status with Clemson.

Financial Aid Partnership	Scholarships are applied to your tuition bills before the semester begins in order for you to pay what your scholarships don't cover. Grades do affect scholarship GPA requirements. Funds can potentially be released for summer sessions if the fall or spring funds have not been used.
Fees	Tuition is approximately \$6,000 for SC residents and \$15,000 for non-residents. Housing is approximately an additional \$5,000. There is a \$200 registration fee for INT 2010.
Paid Internships	\$2,500 stipend. Almost all of the internships reside "on the Hill."
Enrollment Status	Maintained through 15 hours of USC coursework - 9 of the credit hours are through internship and 6 credit hours are through traditional coursework. It is strongly encouraged to maintain enrollment status at Clemson University by enrolling in INT 2010 off-campus internship course.
Room/Board	Included (via a partnership with WISH)
Application	There is an application process and the program limits enrollment to 14 – 17 students every semester. Students should be involved in the Honors College OR have a 3.5 GPA or higher to apply.
